You are entitled to obtain from the Holder the cancellation (the right to be forgotten), limitation, up-dating, correction, portability, opposition to the processing of personal data that concern you and you may exercise all the rights as established in Articles 15, 16, 17, 18, 19, 20, 21, 22 of the GDPR.

UE Regulation 2016/679: Arts. 15, 16, 17, 18, 19, 20, 21, 22 – Rights of the interested party

1. Data subjects are entitled to obtain the confirmation as to whether or not personal data concerning them is held, even if not yet recorded, their intelligible communication and the possibility of complaint to the designated supervisory body.

2. Data subjects shall have the right to obtain the following information:

- a. of the origin of the personal data;
- b. of the purposes and methods of processing;
- c. of the method applied in the case of processing carried out with the aid of electronic means
- d. of the identification data of the holder, the person in charge of the appointed representative according to Article 5, Paragraph 2;
- e. of the subjects or the subject categories to whom the personal data can be communicated or that can get to know them as appointed representative in the territory, of representatives or appointees in charge.

3. Data subjects shall have the right to obtain:

- a. the updating, correction or, when they are interested, additions to the data;
- b. the cancellation, transformation into anonymous form, or blocking of data processed in violation of law, including those that need not be retained for the purpose for which the data were collected or subsequently processed;
- c. certification that the parties to which the data have been transferred or disseminated have been notified of the operations specified in points a) and b), also regarding their content, except for the case where notification proves impossible or requires the use of means clearly disproportionate to the protected right.
- d. data portability.

4. Data subjects are entitled to fully or partially object:

- a. for legitimate reasons, to the processing of personal data regarding them even if it is pertinent to the purpose of its collection;
- b. to the processing of personal data for the dispatch of advertising or direct sales material or for the conduction of market research or business information.
